MEETING TODAY, THE CAD IT BOARD OF DIRECTORS HAS:

- EXAMINED AND ACKNOWLEDGED GIUSEPPE DAL CORTIVO'S RESIGNATION FROM HIS POSITION AS NON-EXECUTIVE DIRECTOR OF CAD IT
- NOMINATED A NEW CAD IT NON-EXECUTIVE INDEPENDENT DIRECTOR BY CO-OPTION.

The CAD IT S.p.A. Board of Directors (www.caditgroup.com), leader in the Italian financial software market and listed in the STAR segment of Borsa Italiana, met today and hereby announces having acknowledged Giuseppe Dal Cortivo's resignation from his position as Non Executive Director of CAD IT. At the same meeting, in accordance with art. 18 of the Company By-laws and art. 2386 of the Italian Civil Code, on prior favourable consent of the Board of Auditors and the Nominating and Remuneration Committee, the Board also nominated, by co-option, the lawyer Debora Cremasco, with experience in the corporate and financial sector, as Non-Executive Independent Director.

Giuseppe Dal Cortivo, already suspended from his functions, communicated his wish to resign in order to protect the interests of the Company and the market in general in view of the Rome Public Prosecutor's investigations to which he is still subject.

The Board of Directors and Board of Auditors, on acknowledging Giuseppe Dal Cortivo's decision, would like to express their unanimous and sincere thanks for the valuable contribution and enormously beneficial commitment that he has made over the years in carrying out his functions and, certain of the correctness of his actions, sincerely hope that the judicial events in question will soon be favourably resolved.

Giuseppe Dal Cortivo, as Non-Executive and Non-Independent Director, was not a member of any internal committee.

In accordance with article 6 of the Corporate Governance Code, the Board of Directors hereby declares:

- not to have paid Giuseppe Dal Cortivo any indemnity at the end of his office;

- not to have acknowledged any monetary and/or non-monetary benefits to Giuseppe Dal Cortivo since the termination of his office;
- that Giuseppe Dal Cortivo was not the beneficiary of any incentive plan based on financial instruments;
- not to have signed any non-competition agreements with Giuseppe Dal Cortivo;
- not to have acknowledged any other remuneration of any kind and/or in any form to Giuseppe Dal Cortivo for his office termination;
- that Giuseppe Dal Cortivo's replacement is not governed by a succession plan since the Company has not adopted one.

The CAD IT S.p.A. Board of Directors has positively evaluated the existence of the independence requirements foreseen by the laws in force in regard to Director Debora Cremasco, who will cover the role of Non-Executive Independent Director on the CAD IT Board of Directors and will not belong to any of the Board's internal committees.

The newly nominated Director, Debora Cremasco, who will hold the position until the next Shareholders' Meeting, on the basis of her declaration to the Company, does not hold, at nomination date, any direct and/or indirect shares in CAD IT.
