**SALE FINALISED OF EQUITY INTERESTS HELD BY SUBSIDIARY “SIAS PARKING”  
IN THE PARKING SECTOR**

The equity interests in Fiera Parking, Parcheggio Piazza Meda, Parcheggio Via Manuzio in Milan, Parcheggio Piazza Vittorio in Turin, Parcheggio Piazza Trento e Trieste in Monza have been sold for a total of €61.5 million.

*Turin, 29 November 2017.* Sias announces that its subsidiary Sias Parking has finalised the sale of its equity interests in the parking sector held in Fiera Parking Spa, Parcheggio Piazza Meda Srl, Parcheggio Via Manuzio Srl in Milan, Parcheggio Piazza Vittorio Srl in Turin, and Parcheggio Piazza Trento e Trieste Srl in Monza, for a total of €61.5 million.

Specifically, Sias Parking has sold its 99.0% stake in “Fiera Parking” to Fondazione Ente Autonomo Fiera Internazionale di Milano for €32 million. Fiera Parking is the company that holds the concession to manage the Rho-Pero car parks at the new Fiera di Milano, under an agreement signed in 2003 with Fondazione Fiera Milano.

The 50% stakes in the companies Parcheggio Piazza Meda Srl and Parcheggio Via Manuzio Srl in Milan, Parcheggio Piazza Vittorio Srl in Turin, and Parcheggio Piazza Trento e Trieste Srl in Monza have also been sold to Parcheggio Italia Spa for €29.5 million.

The sale of the stakes in the parking sector, acquired in November 2014 for a total of €32.7 million, gives full implementation to the new Sias Group guidelines, which are increasingly focused both domestically and internationally on the core business of motorway concessions and the disposal of non-strategic assets.
