In particular, in light of the results contained in the interim financial report as at 30 June 2018, as well as the performance of Vittoria Capital in the first half of 2018, in the opinion of the Offeror, the prospective performance and the performance for the year 2018 of Vittoria Assicurazioni and Vittoria Capital is in line with the information on the expected trends and with the profit forecasts and estimates referred to in paragraphs B.1.22 and B.1.23 of the Offer Document.
