## 9,625,395 RIGHTS OF F.I.L.A. – FABBRICA ITALIANA LAPIS ED AFFINI S.P.A. SOLD FOR A PRICE PER RIGHT OF EURO 0.55 FOR AN OVERALL CONSIDERATION OF EURO 5,293,967

*Milan*, *December 3*, 2018 – Following the press release published on December 3, 2018, Pencil S.p.A. announces the successful conclusion of the placement of 9,625,395 rights (the "**Placement**"), carried out in connection with the share capital increase of F.I.L.A. – Fabbrica Italiana Lapis ed Affini S.p.A (the "**Share Capital Increase**").

In relation to the Placement, Mediobanca – Banca di Credito Finanziario S.p.A. and UniCredit Corporate & Investment Banking – in cooperation with Kepler Capital Markets S.A. – acted as Joint Bookrunners.

In the context of the Placement, carried out through an accelerated bookbuilding process reserved to Italian and international institutional investors, 9,625,395 rights have been sold for a price per right equal to Euro 0.55 for an overall consideration of approx. Euro 5,293,967.

The Placement will be settled on December 6, 2018.
