FinecoBank: Conclusion of Treasury Shares Purchase Programme servicing the 2020 incentive system for Financial Advisors - “2020 PFA PLAN*”

Milan, March 10th, 2021

On March 10th 2021, FinecoBank concluded the Treasury Shares purchase programme to service the 2020 incentive system “2020 PFA PLAN”, initiated on February 10th 2021 and already disclosed to the market also pursuant to art. 144-bis of Consob Issuers Regulation adopted with resolution n. 11971/1999, with reference to the press release issued on February 9th 2021, to which reference is made.

FinecoBank wishes to inform that on March 9th, 2021 it purchased on the MTA (Electronic Stock Exchange) organized and managed by Borsa Italiana S.p.A., n. 25,000 ordinary Fineco shares, equal to 0.0041% of share capital, at the average price of 14.77 Euro per share, for an overall value of 369,250 Euro.

Details of the transactions on a daily aggregated basis are provided below. Detail of each purchase is attached to this press release.

The purchase transactions were carried out in compliance with applicable legislation and regulations, as well as consistent with and within the limits indicated by the shareholders authorization and the related Board implementation resolution.

During the period of implementation of the Program considered as a whole (from February 10th to March 10th, 2021), FinecoBank purchased a total of 55,000 treasury shares, equal to 0.00722% of share capital, at an average unit price of 14.91739 Euro, for a value of 820,546 Euro.

At the date of this press release, the Bank holds 122,866 treasury shares, equal to 0.02016% of share capital.
