TECHNOGYM S.P.A. CALLED FOR MAY 5, 2021 IN SINGLE CALL**

**1. Approval of the Separate Financial Statements at December 31, 2020, together with the Board of Directors' Report on Operations, the Report of the Board of Statutory Auditors and the Independent Auditors' Report. Presentation of the Consolidated Financial Statements at December 31, 2020 and of the consolidated non-financial statement prepared in accordance with Legislative Decree no. 254/2016.**

Dear Shareholders,

concerning the first point in the agenda of the Shareholders' Meeting called for May 5, 2021, we invite you to read the Annual Financial Report of Technogym S.p.A. ("**Technogym**" or the "**Company**") at December 31, 2020, approved by the Board of Directors of Technogym on March 24, 2021 and containing the draft Financial Statements of the Company and the consolidated financial statements, together with the Directors' Report on Operations and with the certification under art. 154-*bis*, paragraph 5, of Legislative Decree no. 58 of February 24, 1998, as amended.

The Board of Directors of March 24, 2020 also approved, with a distinct report from the Directors' Report on Operations, the consolidated non-financial statement prepared in accordance with Legislative Decree no. 254/2016.

The aforesaid documentation shall be made available to the public according to the manners and deadlines prescribed by legal regulations, together with the Report of the Board of Statutory Auditors and the Independent Auditors' Report.

It should be recalled that the consolidated financial statements of the Company at December 31, 2020, which shows a consolidated net profit for the year of Euro 36,003,604.55, as well as the consolidated non-financial statement prepared in accordance with Legislative Decree no. 254/2016 are submitted to you for viewing, but they are not subject to the approval of the Shareholders of the Company.

By referring to these documents, we kindly invite you to approve the Separate Financial Statements at December 31, 2020 that closed with a net profit of Euro 46,339,485.58, recommending to pass the following resolution:
