## UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, August  $16^{th}$ , 202I - - In relation to the share buy-back program resolved by the Shareholders' Meeting of April  $23^{rd}$ , 202I, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period  $6^{th}$  -  $13^{th}$  August, 202I, a total of I80,000 ordinary Amplifon S.p.A. shares, equivalent to 0.080% of the share capital, at an average unit price of Euro 42.269 per share, for a total consideration of Euro 7,608,334.50.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 20II-2020 and Performance Stock Grant Plan 20I4-2021 for a total of n. I3,5II,335 shares.

As of August 13<sup>th</sup>, 2021, Amplifon owns n. 1,589,665 of its shares, corresponding to 0.702% of the Company's share capital and to 0.492% of the total share capital in voting rights.
