## UniCredit: update on the execution of the share buy-back programme during the period from 1 July 2024 to 5 July 2024

Milan, 9 July 2024 – Within the UniCredit S.p.A. (the "**Company**" or "**UniCredit**") share buy-back programme communicated to the market on 21 June 2024 and initiated on 24 June 2024, as per the authorisation granted by the Shareholders' Meeting of the Company held on 12 April 2024 (the "**Third Tranche of the Buy-Back Programme 2023**") – on the basis of the information received from BofA Securities Europe SA as intermediary in charge of executing, in full independence (so-called "*riskless principal*" or "*matched principal*"), the Third Tranche of the Buy-Back Programme 2023 – UniCredit informs, pursuant to art. 2, paragraph 3, of the Delegated Regulation (EU) 2016/1052, that it has carried out the transactions indicated below.
