## UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, August 5<sup>th</sup>, 2023 – In relation to the share buyback program resolved by the Shareholders' Meeting of April 24<sup>th</sup>, 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased in the period July 30<sup>th</sup> – August 2<sup>nd</sup>, 2024, a total of 160,000 ordinary Amplifon S.p.A. shares, equivalent to 0.071% of the share capital, at an average unit price of Euro 28.562 per share, for a total consideration of Euro 4,569,928.29.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

As of August 2<sup>nd</sup>, 2024, Amplifon owned n. 364.799 of its shares, corresponding to 0.161% of the Company's share capital and to 0.113% of the total share capital in voting rights.
