UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, September 23rd, 2024 – In relation to the share buyback program resolved by the Shareholders' Meeting on April 24th, 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased in September 16th, 2024, a total of 40,000 ordinary Amplifon S.p.A. shares, equivalent to 0.018% of the share capital, at an average unit price of Euro 27.443 per share, for a total consideration of Euro 1,097,703.56.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

As of September 20th, 2024, Amplifon owned n. 924.799 of its shares, corresponding to 0.409% of the Company's share capital and to 0.287% of the total share capital in voting rights.
