Periodic disclosure on the buyback program

Ronco Scrivia (GE, Italy), October 7th, 2024 - **Racing Force S.p.A.** (the “**Company**” or “**RFG**”), the parent company of Racing Force Group, which is specialized in the development, production, and marketing of safety components for motorsports worldwide, listed on the Euronext Growth segment in Milan (RFG) and Paris (ALRFG), with regards to the treasury buy-back program authorized by the Shareholders’ Meeting of April 29th, 2024, announces that between September 30th and October 4th, 2024, it acquired on the Euronext Growth Milan segment no. 3.636 RFG shares, equal to 0.0133% of the share capital, at an average price of Euro 4.20 per share for a total of Euro 15,282.88.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.

Following the above stated purchases, RFG currently holds 26,560 treasury shares, equal to 0.0970% of the share capital.
