# GENERALFINANCE: CLEARANCE GRANTED TO OPEN A BRANCH IN SPAIN, THE FIRST OUTSIDE ITALY

## INTERNATIONALIZATION PROJECT INITIATED, ALIGNED WITH DEVELOPMENT GUIDELINES TO BE PRESENTED TO THE MARKET WITH THE NEW STRATEGIC PLAN

### JOSÉ ESCRIBANO GUTIERREZ APPOINTED AS HEAD OF THE SPANISH BRANCH

Milan, 13 December 2024 – Generalfinance, a financial intermediary listed on the STAR segment of Euronext Milan and specialized in the factoring sector, announces that the Bank of Italy has granted the clearance for the opening of a branch in Spain, the first outside Italy. This milestone marks the beginning of an internationalization project, starting with the Spanish market, which shares dynamics similar to those in Italy, including legal protections in the distressed financing sector. The branch is located in Madrid's Azca district, the financial hub of the city.

The objective is to maintain operations and risk control in Italy, while focusing the branch's activities on business development and origination. Over time, the aim is to establish a network in the restructuring sector with key players in the Spanish market, mirroring the approach successfully implemented in Italy.

The opening of this first foreign branch aligns with Generalfinance's goal of expanding its presence at the international level, as part of the initiatives outlined in the new 2025-2027 Business Plan to be presented to the market in the first quarter of next year. This initiative represents a strategic step for the company, aiming to consolidate its presence in new markets and strengthen its position in the factoring sector, with a particular focus on distressed/high-risk companies.

The new Madrid branch will be led by José Escribano Gutierrez, who will serve as Country Manager. Escribano is a seasoned financial professional with over 20 years of experience, particularly in the factoring sector. Previously, he held leadership roles such as Risk Manager at DLL-Rabobank, overseeing risk operations in France, Spain, and Portugal, and as Risk & Operations Manager at John Deere Bank. Most recently, he served as Country Sales Manager Spain at BFF Bank. With his proven expertise in managing financial operations and defining risk strategies, José Escribano Gutierrez will be responsible for building relationships with potential new partners and clients and promoting Generalfinance's presence in the Spanish market.
