# THE BOARD OF DIRECTORS VERIFIED THE REQUIREMENTS OF THE DIRECTOR APPOINTED BY THE SHAREHOLDERS' MEETING

**18 December 2024** - The Board of Directors of Tinexta S.p.A., held today, verified the permanence on the Director Mr. Eugenio Rossetti - whose appointment as a Director following resignation and subsequent co-optation was confirmed by the Ordinary Shareholders' Meeting held on 12 December 2024 - of the requirements established by the law and the Corporate Governance Code - to which the Companies adheres - including independence requirements.
