The renewal will be effective from 01 January 2024 and will remain in force for a period of 10 years, until 31 December 2033.

The Irish tonnage tax regime provides a stable and competitive framework that aligns with our Group's long-term goals, further strengthening our position as a leading player in the international product tanker market."
