THE ORDINARY SHAREHOLDERS' MEETING OF TECHNOPROBE APPROVES THE ASSIGNMENT OF THE CERTIFICATION OF COMPLIANCE OF THE CONSOLIDATED SUSTAINABILITY REPORT PURSUANT TO D.LGS. NO. 125/2024 FOR FINANCIAL YEARS 2024/2026 TO THE AUDIT COMPANY PRICEWATERHOUSECOOPERSS.P.A.

THE ORDINARY SHAREHOLDERS' MEETING OF TECHNOPROBE APPOINTS AN ADMINISTRATOR PURSUANT TO ART. 2386 C.C., FOLLOWING RESIGNATION AND SUBSEQUENT CO-OPTATION

**Cernusco Lombardone (LC), 20 December 2024** – The Ordinary Shareholders' Meeting (the "**Meeting**") of Technoprobe S.p.A., a company listed on Euronext Milan and leader in the design and production of Probe Cards (the "**Company**" or "**Technoprobe**"), held today, approved the assignment of the mandate for attesting the compliance of the consolidated sustainability report to the audit firm PriceWaterhouseCoopers S.p.A., pursuant to Legislative Decree of 6 September 2024 no. 125 (the "**Decree**"), implementing Directive 2022/2464/EU of 14 December 2022 ("**Corporate Sustainability Reporting Directive**" or "**CSRD**"), for the company financial years 2024/2026.

The consolidated sustainability report shall be certified by the audit firm PriceWaterhouseCoopers S.p.A. with reference to:

- \* the compliance of the sustainability report with the rules of the Decree governing its drafting criteria:
- \* the compliance with the requirement of marking sustainability reporting as set out in the Decree;
- \* the compliance with the reporting requirements set out in Article 8 of Regulation (EU) 2020/852.

The Ordinary Shareholders' Meeting also appointed Gregory Stephen Smith - already co-opted as director by virtue of a resolution of the Board of Directors dated May 27, 2024 - as non-executive and non-independent director. Dr Smith will remain in office until the end of the Board's term (that is until the date of approval of the financial statements on 31 December 2026).

The Board member's curriculum vitae and his statements for the purposes of the application are available at the Company's headquarters and on the website www.technoprobe.com (Governance/Shareholders' Meetings).

As of the date of this release, to the best of the Company's knowledge, the newly appointed director, Gregory Stephen Smith, does not hold any shares in the Company.
