Edil San Felice Secures New Contract from ASPI Worth Over €16 Million for Extraordinary Maintenance Works

Naples, April 8, 2025 – Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice") – a leading integrated operator active in the critical infrastructure maintenance sector in Italy and listed on the Euronext Growth Milan market – has been awarded a contract by Autostrade per l'Italia as part of a four-year framework agreement. The contract is valued at €16,215,428.70 (of which €4,378,165.75 are for safety charges) for extraordinary maintenance works.

Specifically, the award concerns a 42% share of Lot 4, for which the Company was selected as a member of the Fenix Consorzio Stabile Società Consortile A R.L. Edil San Felice has been designated as the sole executor and will carry out 100% of the work.

The agreement includes works to strengthen the motorway structure and perform advanced extraordinary maintenance interventions on structures and components along the sections managed by the Florence Branch Directorates.

In this context, Edil San Felice will carry out extensive upgrading works on existing infrastructure with the aim of extending their service life. The interventions will be aimed at improving structural safety—also through waterproofing works—enhancing material durability, eliminating causes of early deterioration, and increasing the sustainability performance of the components.

"The awarding of this contract," commented **Lorenzo Di Palma, CEO of Edil San Felice**, "further confirms our commitment to consolidating Edil San Felice's leadership position within its core sectors, represented by the ordinary and extraordinary maintenance of roads and motorways. The gradual path of diversification, launched in 2024 with our entry into the railway sector and continued in early 2025 with the acquisition of a major contract in the aerospace sector, is certainly a strategic priority for the Company. However, it will be pursued in parallel with our consolidation in our primary markets, where we continue to see significant demand growth, aligned with the need for safe and reliable road infrastructure for citizens."
