ANNOUNCEMENT REGARDING VOTING RIGHTS (ART. 85-*BIS* PARAGRAPH 4-BIS OF ISSUERS' REGULATION AND ART. 2.6.2. PARAGRAPH I PART A) OF BORSA ITALIANA S.P.A. MARKETS RULES)

Milan, April IIth, 2025 – Pursuant to art. 85-bis paragraph 4-bis of the Issuer Regulation adopted by Consob with decision no. II97I of I4 May I999, as well as art. 2.6.2. part a) of the Regulation by Borsa Italiana S.p.A., Amplifon S.p.A. (EXM; Bloomberg ticker: AMP:IM), global leader in hearing solutions and services, informs that as of the record date of the Shareholders' Meeting called for April 23rd, 2025:

- Amplifon S.p.A. share capital equals € 4,527,772.40 and consists of n. 226,388,620 shares with a nominal value of € 0.02 per share;
- The number of shares with accrued increased voting rights (two voting rights per share) is n. 95,495,236 shares out of a total of n. 226,388,620 shares, which implies voting rights equal to 321,883,856;
- Pursuant to subsection 8 of art I27-quinquies of the TUF, the increase of voting rights is calculated to determine the quora to convene the Shareholders' Meeting as well as for it to pass resolutions.

Pursuant to subsection 8 of art I27-quinquies of the TUF, the increase of voting rights is calculated to determine the quora to convene the Shareholders' Meeting as well as to pass resolutions.

It should also be noted that there are further n. 7.444.465 shares registered in the list of increased voting rights; said increase is currently being vested.

Finally, as of today the Company holds I,445,063 treasury ordinary shares with suspended voting rights.
