Senior unsecured notes to be issued by Carraro Finance S.A. due 2030: notice on results of bond Offering

Luxembourg, 14 April 2025 – Following the publication of the prospectus (the “**Prospectus**”) relating to the public offering (the “**Offering**”) and admission to listing and trading on the regulated market of the Luxembourg Stock Exchange (“**LuxSE**”) and on the “Mercato Telematico delle Obbligazioni” (“**MOT**”) organised and managed by Borsa Italiana S.p.A. (“**Borsa Italiana**”) of the *senior unsecured* notes (the “**Notes**”) to be issued by Carraro Finance S.A. (“**Carraro Finance**” or the “**Company**”), approved by the *Commission de Surveillance du Secteur Financier* (“**CSSF**”) on 28 March 2025 and passported into Italy, Carraro Finance hereby announces the results of the Offering.

Capitalised terms used in this notice but not otherwise defined shall have the meaning given to them in the Prospectus.

Notes were sold for an aggregate principal amount of €126,000,000 at an issue price of 100% of the nominal value, represented by no. 126,000 Notes with a nominal value of €1,000 each. The gross proceeds of the Offering will amount to €126,000,000.

The interest rate was determined on 2 April 2025, ahead of the recent market turmoil, and notwithstanding the high volatility scenario throughout the Offering Period, the Group, without amending the issuance conditions, reached its placement target, primarily aimed at early redemption the Euro 120 million bond due 2028, with the consequent outcome of reducing its aggregate debt cost.

The starting date for trading the Notes on the MOT will be set by Borsa Italiana by means of a specific notice issued pursuant to Article 2.4.3 of its Regulation. On the same date, the Notes will also be admitted to listing on the official list and will start trading on the Regulated Market of the Luxembourg Stock Exchange.

The issue date of the Notes as well as the date from which the Notes will accrue interests, will be 17 April 2025. Interests on the Notes, which will accrue at a fixed interest rate of 5,25% per annum, will be paid in arrear on 17 October and 17 April on each year starting from 17 October 2025. The Maturity Date of the Notes is 17 April 2030.

In the context of the Offering, Equita SIM S.p.A. acted as placement agent and as intermediary in charge of the offer and display of sale proposals for the Notes on the MOT.

“The positive outcome of our offer shows the trust of the market in Carraro and our appeal among institutional and retail investors. This circumstance is even more relevant when considering that our bond offering took place during a time of high volatility of the international markets due to the
