Iccrea Banca: S&P Global Ratings upgrades the issuer credit ratings to “BBB/A-2” from “BBB-/A-3”.

S&P Global Ratings has upgraded Iccrea Banca’s long-term and short-term ratings to “BBB/A-2” from “BBB-/A-3”. The outlook is stable.

This rating action reflects the recent sovereign upgrade of Italy followed by an improvement in the rating of the Italian banking sector (*‘BICRA anchor’*).

In this context, S&P believes that the group’s efforts to improve group governance and risks oversight will ultimately lead to a manageable asset quality deterioration even in case of an economic downturn.

Furthermore, in addition to highlighting the Group’s strong capitalization and the solid national franchise, S&P expects the Group will continue to diversify its revenue stream and improve its cost efficiency.

Mauro Pastore, General Manager of BCC Iccrea Group, commented: “S&P Global Ratings’ upgrade adds to a long series of positive recognitions our Group has received in recent years and further strengthens our rating position in the *Investment Grade* area. This upgrade represents also an important acknowledgement of the effectiveness of our business model, which combines continuous support to local communities with the constant improvement of our fundamentals.”
