GRANTING OF POWERS AND APPOINTMENT OF BOARD OF DIRECTORS' COMMITTEES

Reggio Emilia, 5 May 2025 – The Board of Directors of Newlat Food S.p.A. (the "Company" or "Newlat Food" – whose change of denomination to NewPrinces S.p.A. will be effective following the registration of the shareholders' resolution in the Company Register of Reggio Emilia, which will be communicated to the market within the terms of the law), appointed by the Ordinary Shareholders' Meeting held on 28 April, ascertained that the directors Valentina Montanari, Eric Sandrin and Maria Cristina Zoppo meet the independence requirements pursuant to art. 148, paragraph 3, of the Legislative Decree n. 58 of 24 February 1998 (the "TUF") as well as the requirements of the Corporate Governance Code, to which the Company adheres.

The Board of Directors also verified, on the basis of the assessments made by the Board of Statutory Auditors, that Massimo Carlomagno, Ester Sammartino and Antonio Mucci meet the independence requirements pursuant to art. 148, paragraph 3, of the TUF, as well as the Corporate Governance Code requirements for statutory auditors.

The Company then confirmed the powers – already granted in the previous mandate – to the Chairman of the Board of Directors Angelo Mastrolia and appointed Giuseppe Mastrolia as CEO (Markets) and Stefano Cometto as CEO (Operations), also confirming the powers already held in the previous mandate.
