It should be noted that the conversion price identified based on the contractual agreements was set at EUR 0.1450.

Furthermore, the Company informs that today a subscription has been requested in favour of Nice & Green S.A. ('N&G' or the 'Investor') for 10 bonds convertible into Tessellis shares (coupon no. 206 - 215) with a unit value of Euro 100,000 each, which will be issued on May 13, 2025.

It should also be noted that N&G is not - nor has it ever been - qualified as a related party pursuant to the applicable regulations in law.
