CLOSURE OF BUY-BACK PROGRAM

Trezzo sull'Adda (MI), 16 May 2025 – **Cofle S.p.A.** (**EGM: C**FL) – a world-leading company in the design, production and marketing of control cables and actuation systems, operating globally through two divisions: Original Equipment (OE), dedicated to customised systems for the Agritech, Luxury Automotive and off-road vehicle sectors, and Independent After Market (IAM), which produces control cables, brake hoses and EPB systems for the automotive aftermarket – announces that on 16 May 2025 it completed the market purchase of its own shares (the buy-back program) launched on 16 November 2023.

Between 16 November 2023 and 16 May 2025 the Company purchased a total of 102,284 treasury shares.

The purchases were executed by the appointed intermediary acting with full independence and in accordance with the parameters and criteria set out in the Board of Directors' resolution of 16 November 2023.

All transactions were carried out so as to ensure equal treatment of shareholders pursuant to Article 132 of the Italian Consolidated Finance Act (TUF) and in compliance with the operational procedures established by the organisation and management rules of Borsa Italiana S.p.A.

As of today, the Company holds 102,284 treasury shares, representing 1.66 % of its share capital.
