UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, June 3rd, 2025 – Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that in relation to the share buyback program resolved by the Shareholders' Meeting on April 23rd, 2025, it has purchased on the Milan Euronext and on multilateral trading facilities, in the period from May 26th to May 30th, 2025, a total of 351,420 ordinary Amplifon S.p.A. shares, equivalent to 0.155% of the share capital, at an average unit price of Euro 19.9305 per share, for a total consideration of Euro 7,003,976.31.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on daily basis:
