## UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, June 4<sup>th</sup>, 2025 – Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that in relation to the share buyback program resolved by the Shareholders' Meeting on April 23<sup>rd</sup>, 2025, it has purchased on the Milan Euronext and on multilateral trading facilities, in the period from June 2<sup>nd</sup> to June 4<sup>th</sup>, 2025, a total of 290,611 ordinary Amplifon S.p.A. shares, equivalent to 0.128% of the share capital, at an average unit price of Euro 20.135 per share, for a total consideration of Euro 5,851,340.50.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on daily basis:
