Total Net Inflows climb to € 5.4 billion in the first 5 months, Managed Assets Inflows surge to € 3.8 billion

Banca Mediolanum S.p.A. announces the business results for **May 2025: € 866 million**, of which:

- Total net inflows: **€ 492 million, € 5.38 billion YTD**
- Net inflows into managed assets: **€ 633 million, € 3.78 billion YTD**
- Loans granted: **€ 353 million, € 1.51 billion YTD**
- General insurance premiums: **€ 20 million, € 93 million YTD**

Massimo Doris, CEO of Banca Mediolanum, commented: "May net inflows of 492 million euro were solid and high quality, also considering the 633 million euro recorded in our managed asset solutions. While the month was marked by higher-than-normal outflows from current accounts due to tax deadlines for customers in Italy, the transformation of administered assets into managed continues, driven by the valuable advice of our Family Bankers. All of this allows us to close the first five months of 2025 with 3.8 billion euro in net inflows into managed assets - a level that represents a solid base for reaching our targets for the year".

Doris concluded: "I would also underline the strong acceleration in the granting of mortgages and loans - 353 million euro in the month and 1.5 billion euro year-to-date - a testament to the positive combination of better market conditions and a product offer that is focused on the needs of the customers".
