Sant'Angelo di Piove di Sacco (Padua), June 9, 2025 – Energy S.p.A., an Italian company listed on the Euronext Growth Milan market, (ISIN Code IT0005500712, Ticker ENY), parent company of the Energy Group, a full system technology manufacturer, BESS (Battery Energy Storage System) leader and cloud and engineering services provider, announces, pursuant to Article 2436, paragraph 6, of the Civil Code, that it has filed the new text of its By-Laws with the Trento Companies Register, updated following the cancellation by the Board of Directors of n. **3,792,000 of the third and last tranche of Price Adjustment Shares 2024**.

Energy's share capital of Euro 616,605.80 remains unchanged, now divided into n. 54,076,580 ordinary shares with no express indication of nominal value.
