### Launch the treasury share buyback program.

*Cernusco Lombardone (LC), July 22, 2025* – Technoprobe S.p.A., a company listed on Euronext Milan and a leader in the design and manufacture of Probe Cards (the “**Company**” or “**Technoprobe**”), announces that, following the Board of Directors resolution on July 10, 2025, the share buyback program will start on July 23, 2025.

Treasury share purchases will be carried out through an appointed intermediary, identified as Intesa Sanpaolo S.p.A., exclusively on Euronext Milan – EXM managed by Borsa Italiana S.p.A., in accordance with the methods established by Borsa Italiana S.p.A., which do not allow the direct matching of purchase orders with predetermined sale proposals, as permitted by Article 132, paragraph 1, of the TUF and Article 144-bis, paragraph 1, letter b), of the Issuers’ Regulation adopted by CONSOB with resolution no. 11971/1999 (also through subsidiaries).

The reporting of transaction will be disclosed to the market in accordance with the terms and conditions set out in the laws and regulations in force.
