UPDATE ON THE EXECUTION OF THE SHARE BUYBACK PROGRAMME DURING THE PERIOD FROM AUGUST 18 TO AUGUST 22, 2025

Milan, August 25th, 2025 – With reference to the execution of the share buyback programme, which was disclosed to the market on May 21, 2025 and initiated on the same date, Nexi S.p.A. (“Nexi”), communicates that - on the basis of information provided by BofA Securities Europe SA, the third-party intermediary appointed to execute the programme in full independence and without any involvement of Nexi - from August 18, 2025 to August 22, 2025 the intermediary executed the purchase transactions summarised in the table below, on a daily basis in aggregate form, on both regulated market and Multilateral Trading Facilities:

As of August 22, 2025, Nexi had purchased a total of 54,470,304 shares since the launch of the programme, equal to around 4.43% of its share capital, at an average weighted purchase price of 5.0844 euro per share, for a total countervalue of 276,946,257.47 euro.
