(**Italmobiliare** o la **Società**) comunica che, nell'ambito del programma di acquisto di azioni proprie (il Programma) deliberato dall'assemblea degli azionisti del 17 aprile 2025, annunciato il 30 giugno 2025 e avviato il 3 luglio 2025, dal 25 agosto 2025 al 29 agosto 2025 sono state acquistate complessivamente sul segmento Euronext STAR Milan - Borsa Italiana, n. 12.019 azioni, pari allo 0,028% del capitale, a un prezzo medio unitario di euro 28,2571 per azione, e per un controvalore complessivo di euro 339.622,40.

UPDATE ON THE EXECUTION OF THE BUY BACK PROGRAM

Milan, September 1, 2025 – Italmobiliare S.p.A. (**Italmobiliare** or **the Company**) announces that under the treasury share buyback program (the Program) resolved by the shareholders' meeting on April 17, 2025, announced on June 30, 2025 and launched on July 3, 2025, from August 25, 2025 to August 29, 2025, a total of 12,019 shares, equal to 0.028% of the issued share capital, were purchased on Euronext STAR Milan - Borsa Italiana at an average price per share of euro 28.2571 and for a total countervalue of 339,622.40 euro.

On the basis of the information provided by the intermediary in charge of implementing the Program in full independence, the details of the transactions on a daily basis in aggregated form are given below.
