THE ASTM GROUP ANNOUNCES A POTENTIAL BOND ISSUE

Tortona, 7th October 2025. **ASTM SpA**, ("ASTM"), the world's second-largest motorway concession operator and a leader in large-scale projects and applied infrastructure technology, announces its intention to proceed with a new issue of *senior unsecured* bond under its *Euro Medium Term Note* (EMTN) Programme, reserved exclusively to qualified investors and denominated in euro.

Regarding the potential issue, ASTM has appointed as *joint bookrunners*: Banca Akros, BNP Paribas, Caixabank, Crédit Agricole CIB, IMI-Intesa Sanpaolo, JP Morgan, Mediobanca, Morgan Stanley, Santander, Société Générale, UBS and UniCredit.
