ANNOUNCEMENT OF TOTAL AMOUNT OF VOTING RIGHTS

Unipol Assicurazioni S.p.A. (“**Unipol**” or the “**Company**”) announces that - as indicated in communication received on 7, 9 and 10 October 2025 - the increased voting rights with respect to 8,411,818 ordinary shares no longer applies, in accordance with article 127-*quinquies* of the Consolidated Law on Finance, the provisions of the articles of association and the Regulations on shares with increased voting rights implemented by the Company and available on its web site under the *Investors/shareholding-structure/increased-voting-rights* section.
