Morningstar DBRS upgrades Iccrea Banca's Long-Term Issuer rating by one notch to "BBB (high)" from "BBB".

Mauro Pastore, GM of BCC Iccrea Group: "A further recognition of the soundness of our business model and our solidity, at the top of the Italian and European banking system".

Morningstar DBRS upgraded the ratings of Iccrea Banca SpA, parent company of the BCC Iccrea Group; specifically, the Long-Term Issuer Rating has improved to BBB (high) from BBB and the Short-Term Issuer Rating to R-1 (low) from R-2 (high). The trend is stable on all ratings.

This upgrade reflects the structural improvement in the Group's profitability, supported by initiatives aimed at diversifying revenues, maintaining strict cost discipline, and reducing the cost of credit.

In addition, the rating upgrade considers that, despite the uncertain environment, asset quality has continued to improve thanks also to the Group's proactive de-risking strategy. According to the agency, in case of an economic slowdown, the Group will benefit from both high coverage of non-performing loans and careful credit management, as evidenced by NPL ratios in the Group's key portfolios (households and SMEs) that are below the peer average.

Finally, the credit ratings continue to reflect the Group's adequate liquidity position and very ample capital buffers, among the highest in Europe.

Mauro Pastore, General Manager of the BCC Iccrea Group, commented: "Today's Morningstar DBRS rating upgrade adds to the many positive recognitions our Group has received in recent years from the financial markets. Since its establishment, the Group has pursued a virtuous path continuously strengthening its fundamentals and achieving one of the highest levels of solidity in the Italian and European banking sectors, while remaining true to its mission and values of cooperative credit and its commitment to supporting core customers."
