By 28 February 2026	Review and approval of the draft of Separate Financial Statements and the Consolidated Financial Statements for the year ended 31 December 2024
By 28 February 2026	Review and approval of the Additional periodic financial information at 31 March 2025
By 28 February 2026	Review and approval of the Half-Year Financial Report as of 30 June 2025
By 28 February 2026	Review and approval of the Additional periodic financial Report as of 30 September 2025

The Board of Directors also expects that the Shareholders' meeting that shall approve the financial statements for the year ending on 31 December 2024 to be held by April 2026 in a single call.
