PIÙ MEDICAL ADMITTED TO TRADING ON EURONEXT GROWTH MILAN

**MARKET CAPITALIZATION¹ OF THE COMPANY AT THE START OF TRADING EQUAL TO

Castronno (VA), 18 November 2025 - **Più Medical S.p.A.** (“**Più Medical**”, the “**Company**”), consolidation platform with a *buy-fix-scale* model active in the retail pharmacy sector and focused, as of the date of this press release, on the Lombardy region announces that it has today received from Borsa Italiana S.p.A. (“**Borsa Italiana**”) the procedure of admission to trading of its ordinary shares (the “**Shares**”, ticker: PMED) on the Euronext Growth Milan multilateral trading facility, organized and managed by Borsa Italiana.

The starting date for trading on Euronext Growth Milan, delivery, and payment of the Offered Shares is scheduled for Thursday, November 20, 2025.

The admission followed a reserved placement for qualified investors in Italy, other Member States of the European Economic Area, and the United Kingdom, as well as foreign institutional investors outside the United States of America (the “**Placement**”) the terms of which are referred to in the previous press release issued today.

The composition of Più Medical's share capital expected at the beginning of trading is shown below, taking into account the n. 1.950.000 ordinary shares subscribed and/or sold as part of the Placement (excluding the possible exercise of the *over-allotment* option and the *greenshoe* option, as described in the Admission Document) and taking into account the investment by First SICAF S.p.A. as *anchor investor*:

The Company

Più Medical is a consolidation platform with a buy-fix-scale model, established in 2025 and focused on the retail pharmacy sector in Northern Italy. The Group currently manages a network of 16 pharmacies. The Group's activity focuses on the management and enhancement of local pharmacies through a centralized operating model that integrates industrial, managerial, and commercial expertise. Più Medical is characterized by an approach geared towards efficiency and profitability, based on structured processes, economies of scale, and a governance model capable of supporting future growth.
