PRESS RELEASE SHARE BUY BACK

Reggio Emilia, 5 December 2025 - NewPrinces S.p.A. (the "Company" or "NewPrinces") announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders' Meeting of 28 April 2025, in the period from 1 November to 30 November 2025, the Company bought back a total of 162,188 ordinary shares on the Mercato Telematico Azionario (equal to 0.37% of the share capital) at an average share price of € 18.56 and for a total value of € 2,915,138.28.
