### **COMMUNICATION OF THE TOTAL AMOUNT OF VOTING RIGHTS**

(drawn up pursuant to art. 85-bis, paragraph 4-bis, Consob Regulation no. 11971 of 14 May 1999)

**Milan, 22 December 2025.** Pursuant to Article 85-bis, paragraph 4-bis of the Issuers' Regulation adopted by Consob with Resolution No. 11971 of May 14, 1999 (the "Issuers' Regulation"), Generalfinance S.p.A. (the "**Company**") hereby communicates that on December 14 and 22, 2025, following the expiration of the twenty-four-month period of continuous registration in the specific list provided for by Article 6, paragraph 5 of the Company's By-laws, certain shareholders accrued the increase provided for by Article 6, paragraphs 5 and 6, letter (a) of the By-laws.. As a result, the Company hereby provides an update on the total number of voting rights exercisable in relation to the Company's shares, indicating the number of shares comprising the share capital.
