SNAM ANNUNCIA IL PREZZO DI CONVERSIONE DEL GREEN BOND CONVERTIBILE IN AZIONI ORDINARIE ESISTENTI DI ITALGAS E CON SCADENZA NEL 2031 PER UN IMPORTO NOMINALE DI 500 MILIONI DI EURO E IL PREZZO DI RIACQUISTO FINALE DELLE OBBLIGAZIONI ATTUALMENTE IN CIRCOLAZIONE CONVERTIBILI IN AZIONI ORDINARIE ESISTENTI DI ITALGAS E CON SCADENZA NEL 2028

Milano, 9 gennaio 2026 – Facendo seguito ai due comunicati stampa pubblicati in data 7 gennaio 2026, Snam S.p.A. (l'“**Emittente**” o “**Snam**”) annuncia che il prezzo di riferimento in relazione ai *green bonds* per un importo totale di €500 milioni con scadenza al 2031 (le “**Obbligazioni**”) e convertibili in azioni ordinarie esistenti di Italgas S.p.A. (le “**Azioni**”) (ISIN XS326658952) e al contestuale riacquisto (il “**Riacquisto**”) dei titoli dell'Emittente c.d. “3.25% €500m EU Taxonomy-aligned Transition Bonds” attualmente in circolazione e con scadenza 2028 (ISIN: XS2693301124) (le “**Obbligazioni 2028**”) è stato fissato ad €10,4521 (determinato come la media aritmetica dei prezzi medi ponderati delle Azioni durante il periodo tra il 7 gennaio 2026 e il 9 gennaio 2026 (entrambe le date incluse).

Come annunciato in data 7 gennaio 2026, il premio di conversione è stato fissato al 25%, che si traduce in un prezzo di conversione iniziale implicito per Azione delle Obbligazioni di €13,0651.

L'*exchange property* consisterà inizialmente in circa 38,3 milioni di Azioni, che costituiscono approssimativamente 3,8% del capitale sociale di Italgas S.p.A. e 33,1% della quota di capitale sociale detenuta da Snam ad oggi. L'*exchange property* potrà essere soggetto ad aggiustamento in talune circostanze come previsto nei termini e condizioni delle Obbligazioni. Al ricevimento di una *exchange notice* da parte di un obbligazionista, Snam può scegliere di corrispondere un importo alternativo in contanti in luogo della consegna di una parte o della totalità della corrispondente quota *pro rata* dell'*exchange property*. In ogni caso, Snam può consegnare un numero massimo di Azioni incluse nell'*exchange property* agli obbligazionisti entro i limiti previsti dagli accordi parasociali stipulati con CDP relativi a Italgas S.p.A., i quali, tra l'altro, stabiliscono attualmente una soglia minima della partecipazione che Snam deve mantenere in Italgas S.p.A., pari al 6,75% del capitale sociale di quest'ultima.

L'Emittente ha riacquisito con successo un importo nominale complessivo di Obbligazioni 2028 per €494.300.000, che rappresenta il 98,9% delle Obbligazioni 2028. Il prezzo di riacquisto finale per Obbligazione 2028 è uguale ad €187.703,48 ed insieme agli interessi maturati fino al 14 gennaio 2026 (escluso), corrisponde ad €188.664,12.
