## **SNAM ANNOUNCES THE EXCHANGE PRICE OF ITS €500M GREEN BONDS EXCHANGEABLE INTO EXISTING ORDINARY SHARES OF ITALGAS DUE 2031 AND THE FINAL REPURCHASE PRICE OF THE OUTSTANDING EXCHANGEABLE BONDS DUE 2028**

**Milan, 9 January 2026** – Following the two press releases published on 7 January 2026, Snam S.p.A. (the **Issuer** or **Snam**) announces that the reference share price in relation to the new €500m green exchangeable bonds (ISIN XS326658952) (the **Bonds**) and the concurrent repurchase (the **Repurchase**) of the Issuer's outstanding 3.25% €500m EU Taxonomy-aligned Transition Bonds due 2028 (ISIN: XS2693301124) (the **2028 Bonds**) has been set at €10.4521 (being the average of the daily volume-weighted average prices of the ordinary shares of Italgas S.p.A. (the **Shares**) during the period starting on (and including) 7 January 2026 and ending on (and including) 9 January 2026).

As announced on 7 January 2026, the exchange premium was set to 25%, which results in an initial implied exchange price per Share of the Bonds of €13.0651.

The exchange property will initially comprise approximately 38.3 million Shares, which represent approximately 3.8% of Italgas S.p.A. listed share capital and approximately 33.1% of Snam's stake as of today. The exchange property will be subject to customary adjustments pursuant to the terms and conditions of the Bonds. Upon delivery of an exchange notice by a bondholder, Snam may elect to pay a cash alternative amount instead of delivering some or all of the relevant pro rata share of the exchange property. In any case, Snam is allowed to deliver a maximum number of Shares in the exchange property to the bondholders within the limits set forth under the shareholders' agreements entered into with CDP related to Italgas S.p.A., which currently, *inter alia*, set forth a minimum threshold for the Snam's stake to be held in Italgas S.p.A. equal to 6.75% of its listed share capital.

The Issuer has successfully repurchased 2028 Bonds in an aggregate nominal amount of €494,300,000, representing 98.9% of the 2028 Bonds. The final purchase price per 2028 Bond amounts to €187,703.48 plus accrued interest up to but excluding 14 January 2026, equal to €188,664.12.

BNP PARIBAS, Goldman Sachs International and J.P. Morgan acted as structuring banks in the offering of the Bonds (the **Structuring Banks**) and, together with BofA Securities, Intesa Sanpaolo, and UniCredit, they acted as joint global coordinators and joint bookrunners (the **Joint Global Coordinators and Joint Bookrunners**). The Structuring Banks also acted as joint dealer managers (the **Joint Dealer Managers**) on the Repurchase.
