CDP, the global non-profit organisation that monitors, among other things, corporate performance in the fight against climate change, has published its latest score for CAREL, awarding the Group an “A–” rating. This represents a further improvement compared to the previous year and places CAREL in the “Leadership” segment, alongside the companies most committed to tackling climate change.

Performance in the area of Water Security was also positive. In this category, CDP awarded CAREL a score of “B”, marking a significant year-on-year improvement.

**Francesco Nalini, CEO of the CAREL Group, and Carlotta Rossi Luciani, member of the Board of Directors in charge of ESG, jointly commented:** *“The excellent result achieved adds to the award of the Silver Medal by EcoVadis and the validation by the Science Based Targets initiative (SBTi) of our short-term emissions reduction targets (near-term targets). The continuous improvement in the main ESG ratings confirms that sustainability is now fully embedded in the CAREL Group’s development strategy and represents a tangible driver of competitiveness, innovation and long-term value creation. The CAREL Group is a global leader in the design, production and marketing of technologically-advanced components and solutions for excellent energy efficiency in the control of heating, ventilation and air conditioning (“HVAC”) and refrigeration equipment and systems. CAREL is focused on several vertical niche markets with extremely specific needs, catered for with dedicated solutions developed comprehensively for these requirements, as opposed to mass markets.

The Group designs, produces and markets hardware, software and algorithm solutions aimed at both improving the performance of the units and systems they are intended for and for energy saving, with a globally-recognised brand in the HVAC and refrigeration markets (collectively, “HVAC/R”) in which it operates and, in the opinion of the Company’s management, with a distinctive position in the relevant niches in those markets.

HVAC is the Group’s main market, representing 71% of the Group’s revenues in the financial year to 31 December 2024, while the refrigeration market accounted for 29% of the Group’s revenues.

The Group commits significant resources to research and development, an area which plays a strategic role in helping it maintain its position of leadership in the reference HVAC/R market niches, with special attention focused on energy efficiency, the reduction of environmental impact, trends relating to the use of natural refrigerant gases, automation and remote connectivity (the Internet of Things), and the development of data-driven solutions and services.
