**Communication of changes to the El.En.'s share capital**

**Firenze, January 19<sup>th</sup>, 2026** – El.En. s.p.a., leader on the laser market listed on the Euronext STAR Milan ("STAR") of the Italian Stock Exchange, hereby gives notice of the changed amount of its share capital pursuant to art. 85-bis Consob Issuers' Regulation.

Following the exercise by certain beneficiaries of the 2016-2025 Stock Option Plan approved by the Board of Directors on September 13<sup>th</sup>, 2016, of the options granted to them for the subscription of newly issued ordinary shares, the company issued, in the period included between December 24<sup>th</sup>, 2025, and December 31<sup>st</sup>, 2025, n. 10.000 ordinary shares for an amount of nominal euro 325,00.

It is further noted that on December 31<sup>st</sup>, 2025, the deadline for the subscription of the divisible capital increase resolved pursuant to Article 2443 of the Italian Civil Code by the Board of Directors on September 13<sup>th</sup>, 2016, in connection with the 2016-2025 incentive plan addressed to directors and employees of El.En. S.p.A. and its subsidiaries, has definitively expired.

Therefore, as of December 31<sup>st</sup>, 2025, the El.En.'s share capital signed and paid-in amounts to euro 2.612.497,94 equal to n. 80.384.552 ordinary shares.

The certification concerning the new amount of the share capital has been filed for registration with the Register of Companies of Florence as of today's date.
