TERNA: 2026 CALENDAR OF CORPORATE EVENTS

Rome, 29 January 2026 – Terna S.p.A. (“Terna”) publishes the 2026 calendar of corporate events:

26 March 2026	Board of Directors meeting to approve the Annual Report for 2025, which contains the report on operations, including the sustainability reporting for 2025, Terna S.p.A. separate and Terna Group consolidated financial statements for the year ended 31 December 2025 and the proposed profit allocation.
7 May 2026	Board of Directors meeting to approve the Interim Report as at 31 March 2026.
29 July 2026	Board of Directors meeting to approve the Interim Financial Report as at 30 June 2026.
12 November 2026	Board of Directors meeting to approve the Interim Report as at 30 September 2026.

Conference calls will be held following the above Board of Directors meetings in order to present the financial results to the market.

It is expected that, during the second half of the year, on a date to be set at a later stage, a meeting of the Board of Directors will be held to update the multi-year Industrial Plan.

The Shareholders Meeting called to approve Terna S.p.A.’s financial statements as of 31 December 2025, as well as the profit allocation, will take place in a single call on 12 May 2026.

Finally, the payment of ordinary dividends in 2026 will take place as follows:

24 June 2026	payment of the final dividend for 2025, with an ex-dividend date of 22 June 2026 (the record date in accordance with art. 83-terdecies of Italian Legislative Decree no. 58 of 24 February 1998, the Consolidated Law on Finance (CLF) will be: 23 June 2026).
25 November 2026	payment of interim dividend for 2026, with an ex-dividend date of 23 November 2026 (the record date in accordance with art. 83-terdecies of Italian Legislative Decree no. 58 of 24 February 1998, the Consolidated Law on Finance (CLF) will be: 24 November 2026).

Any changes to the above calendar will be promptly announced to the market.
