REGISTRATION WITH THE COMPETENT COMPANIES' REGISTERS OF THE PLAN FOR THE MERGER BY ABSORPTION OF BANCA POPOLARE DI SONDARIO INTO BPER BANCA

Modena/Sondrio – 5 February 2026 – Notice is hereby given that, following the release by the competent Supervisory Authorities on 27 January 2026 of the authorizations for the merger by absorption (the “**Merger**”) of Banca Popolare di Sondrio S.p.A. (“**BP Sondrio**”) into BPER Banca S.p.A. (“**BPER**” and, jointly with BP Sondrio, the “**Companies Participating in the Merger**”), the related merger plan – approved by the respective Boards of Directors of the Companies Participating in the Merger on 5 November 2025 – has been registered on 4 February 2026 with the Companies’ Registers of Modena and on 5 February 2026 with the Companies’ Registers of Sondrio, pursuant to and for the purposes of Article 2501-ter of the Italian Civil Code.
