CLARIFICATIONS REGARDING THE FINANCIAL CALENDAR 2026

Colleferro (Rome), 11 February 2026 – Further to the press release published on 29 January 2026, Avio S.p.A. ("Avio" or the "Company") announces that, pursuant to the reporting obligations set forth in the Instructions accompanying the rules of the markets organised and managed by Borsa Italiana (Title IA.2, Section IA.2.1, Article IA.2.1.3), the payment of any dividend relating to 2025 results will take place in May 2026. The Company also specifies that no decision has yet been taken regarding the possible distribution of a dividend.

Avio, as a company listed on the Euronext STAR Milan, will publish – pursuant to Article 2.2.3, paragraph 3 of the Rules of the Markets organised and managed by Borsa Italiana – the additional periodic financial information as of 31 March 2026 and 30 September 2026, containing the minimum content required by Articles 154-ter, paragraph 5, of Legislative Decree 58/1998 ("TUF") and 82-ter of Consob Regulation No. 11971/1999 (Issuers' Regulation), as subsequently supplemented and amended – within 45 days from the end of the first and third quarters of the financial year, respectively. It is also noted that, pursuant to Article 2.2.3 of the Rules of the Markets organised and managed by Borsa Italiana, in lieu of the additional financial information relating to the fourth quarter of 2025, the Company will publish the annual financial report, together with the other documents referred to in Article 154-ter, paragraph 1, of the TUF, within 90 days from the end of the 2025 financial year.

Any amendments to the above calendar will be promptly communicated.
