The platform enables the **secure and federated collection, management, and analysis of clinical data at European level**, allowing artificial intelligence models to be trained directly at healthcare facilities without transferring sensitive data.

The project, funded by the European Union and to be illustrated by Datrrix CTO, Michele Compare, along with Dr. Stephana Carelli from Buzzi Hospital and Prof. Pietro Pinoli from Politecnico di Milano, represents not only a model of collaboration between technology, clinical practice, and research but, above all, a concrete example of how Datrrix operates in the healthcare market: by enabling secure, decentralized, and ready-for-real-adoption AI infrastructures.
