(**Italmobiliare** o la **Società**) comunica che, nell’ambito del programma di acquisto di azioni proprie (il Programma), effettuato a valere sulla delibera dell’assemblea degli azionisti del 17 aprile 2025, annunciato l’11 marzo 2026 e avviato il 16 marzo 2026, dal 16 marzo 2026 al 20 marzo 2026 sono state acquistate complessivamente sul segmento Euronext STAR Milan - Borsa Italiana, n. 18.600 azioni, pari allo 0,044% del capitale, a un prezzo medio unitario di euro 25,2261 per azione, e per un controvalore complessivo di euro 469.205,00.

UPDATE ON THE EXECUTION OF THE BUY BACK PROGRAM

Milan, March 23, 2026 – Italmobiliare S.p.A. (**Italmobiliare** or **the Company**) announces that under the treasury share buyback program (the Program) carried out according to the resolution taken by the shareholders' meeting on April 17, 2025, announced on March 11, 2026 and launched on March 16, 2026, from March 16, 2026 to March 20, 2026, a total of 18,600 shares, equal to 0.044% of the issued share capital, were purchased on Euronext STAR Milan - Borsa Italiana at an average price per share of euro 25.2261 and for a total countervalue of 469,205.00 euro.

On the basis of the information provided by the intermediary in charge of implementing the Program in full independence, the details of the transactions on a daily basis in aggregated form are given below.
