UPDATE ON THE EXECUTION  
AND CONCLUSION OF THE BUY BACK PROGRAM

Milan, April 17, 2026 – Italmobiliare (**Italmobiliare** or **the Company**) announces that under the treasury share buyback program (the Program), carried out according to the resolution taken by the shareholders' meeting on April 17, 2025, announced on March 11, 2026 and launched on March 16, 2026, from April 13, 2026 to April 17, 2026, a total of 11,732 shares, equal to 0.028% of the issued share capital, were purchased on Euronext STAR Milan – Borsa Italiana at an average price per share of euro 28.9475 and for a total countervalue of 339,612.35 euro.

On the basis of the information provided by the intermediary in charge of implementing the Program in full independence, the details of the transactions on a daily basis in aggregated form are given below. Details of the transactions carried out during the period are attached.

The Program ends today, with the total purchase from March 16, 2026, to April 17, 2026, of 56,078 shares (0.132% of the share capital) at an average unit price of euro 26.8413 per share, for a total value of 1,505,209.10. The Program concerned the purchase up to a maximum of 300,000 shares, corresponding to 0,706% of the issuer's share capital, for a maximum consideration of euro 10,000,000.

As of today, the Company holds a total of 484,053 treasury shares representing 1.139% of the share capital.
