### SHARE CAPITAL INFORMATION AND VOTING RIGHTS

(art. 85-bis, paragraph 4-bis, of Consob Regulation n. 11971/1999)

*Cernusco Lombardone (LC), 29 April, 2026* – Notice is hereby given that, as of today, as represented in the following table (i) the subscribed and paid in share capital of the company Technoprobe S.p.a. (the “**Company**”) is equal to Euro 6,532,608.70 and it is divided into no. 653.260.870 ordinary shares without a nominal value, of which no. 226,309,542 with one vote right per each and no. 426,951,328 with two vote rights per each since they have obtained the increase of the voting rights pursuant to art. 7 of the Statute; (ii) the total number of voting rights is equal to no. 1,080,212,198. The Company points out a decrease compared to what was communicated on April 15, 2026, regarding the total amount of voting rights.

It should also be noted that there are further n. 85,735,606 shares registered in the list of increased voting rights (a total of two votes per share); said increase is currently being vested.

As of today the Company holds n. 12,941,522 treasury ordinary shares with suspended voting rights.
