WEEKLY UPDATE ON THE SHARE BUY-BACK PROGRAM

Pero, 18 May 2026 – Fabbrica Italiana Lapis ed Affini S.p.A. (the “Company” or “Fila”) announces to have purchased on Euronext Milan, STAR segment, on 15 May 2026, following the end of the black-out period provided for under the Company’s internal dealing code, no. 25,000 ordinary shares (equal to approximately 0.05% of the share capital) at a weighted average price of Euro 8.926236, for a total consideration of Euro 223,155.84.

Such transactions were carried out as part of the share buy-back program authorized by the Company’s Board of Directors on 23 March 2026, pursuant to the authorization approved by the Ordinary Shareholders’ Meeting of 29 April 2025 (already disclosed pursuant to Article 144-*bis* of Consob Regulation no. 11971/99 and Article 132 of Legislative Decree no. 58/98), whose continuation was confirmed by the Board of Directors on 14 May 2026 following the renewal of the authorisation to purchase and dispose of treasury shares approved by the Ordinary Shareholders’ Meeting held on 29 April 2026.

The purchases have been carried out through the independent intermediary Intermonte SIM S.p.A.

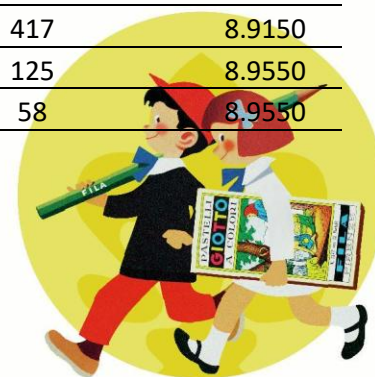

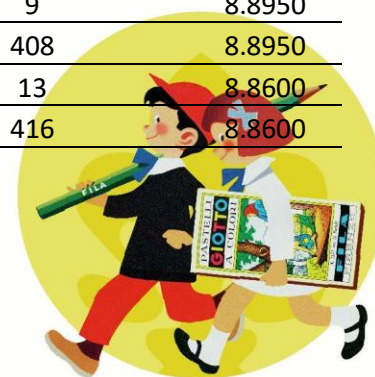
