Assimoco Group – BCC Iccrea Group: partnership extended to 2038. The Assimoco Group increases its stake in BCC Assicurazioni to 70%.

Rome, 26th of May 2026

The Assimoco Group, the leading insurance provider for the Italian cooperative movement and a Benefit Corporation, and the BCC Iccrea Group, the largest cooperative banking group in Italy with 111 Cooperative Credit Banks, have finalized the agreement under which Assimoco has acquired an additional 19% stake in the capital of BCC Assicurazioni, bringing its total shareholding to 70%.

The transaction is part of the agreements signed in 2024 between the two parties and was made possible by the achievement of the targets.

The strengthening of Assimoco Group's presence in BCC Assicurazioni consolidates the path started in April 2024, when Assimoco acquired 51% stake in the company dedicated to offering non-life protection products to the Cooperative Credit Banks belonging to the BCC Iccrea Group.

Concurrently with the financial transaction, the distribution agreement between Assimoco and BCC Iccrea Group has also been extended until 31 December 2038, confirming the strategic, solid and long-term nature of the partnership.

Mirella Maffei, General Manager of Assimoco, comments: "The increase in the stake in BCC Assicurazioni represents a further step in the growth strategy developed together with the BCC Iccrea Group. This transaction further consolidates Assimoco's presence in the bancassurance sector linked to cooperative banking and strengthens the foundations for a sustainable and long-term growth of the partnership."

"This further agreement confirms the goodness of the path undertaken with the Assimoco Group for the benefit of the customers of our 111 BCCs, whether they be individuals, families or SMEs" – added Mauro Pastore, General Manager of the BCC Iccrea Group. – "Our goal is to offer local

communities a comprehensive and competitive offering, and thanks to this partnership our BCCs will be able to remain a point of reference for the communities they serve, including for their non-life insurance needs”.

The BCC Iccrea Group is the largest cooperative banking group in Italy and the 9th largest worldwide in terms of revenue. It is also the only national banking group with entirely Italian capital, the second in terms of number of branches and one of the five systemically important institutions. The Group, at the top of the system in terms of capital strength, currently comprises 111 cooperative credit banks, operating in over 1,600 Italian municipalities with over 2,400 branches, and other banking, financial and instrumental companies controlled by BCC Banca Iccrea. The Group is affiliated with Tertio Millennio ETS Foundation, a nonprofit organization established in 2002 within the Cooperative Credit system, dedicated to promoting social solidarity activities in Italy and abroad.
