**GENTILI MOSCONI:  
THE BOARD OF DIRECTORS APPROVED  
CONSOLIDATED REVENUES FOR THE FIRST QUARTER OF 2026  
AND THE NET FINANCIAL POSITION AS AT 31 MARCH 2025**

- **Consolidated revenues grew significantly to €16.9 million compared to €10.8 million in Q1 2025**
- **Organic growth, at constant perimeter, equal to +9.6%, in continuity with the progressive recovery of the business already emerged in the second half of 2025**
- **NFP “cash positive” of € 7.6 million compared to € 12.0 million as of 31 December 2025**

*Casinate con Bernate (CO), 29 May 2026* – Today the Board of Directors of **Gentili Mosconi S.p.A** (“Gentili Mosconi”) – a group listed on *Euronext Growth Milan* of the Italian Stock Exchange since February 2023 and a Benefit Company, active in the creation, production, printing and customization of fabrics serving the leading international players in the luxury world - met to approve the Revenues for the first quarter of the current financial year and the Net Financial Position as at 31 March 2026.

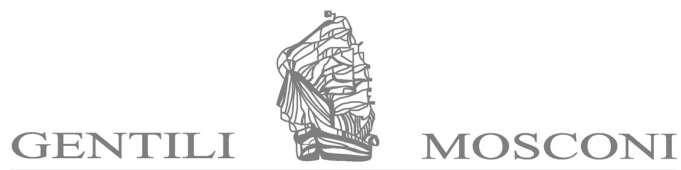
In the first quarter of 2026, Consolidated **Revenues** amounted to **€ 16.9 million**, recording a significant growth compared to € 10.8 million recorded in the same period of 2025. The increase, equal to approximately 56.7%, is mainly attributable to the consolidation (effective from April 2025) of *Manifatture Tessili Bianchi 1981 S.r.l.*, in addition to the significant improvement of orders (mainly accessories) compared to the same period of the previous year, a trend already observed starting from April 2025 and confirmed in the second part of the year.

On a like-for-like basis – and therefore excluding the contribution of *Manifatture Tessili Bianchi 1981 S.r.l.* and to a lesser extent to *Cesare Gatti S.r.l.*, acquired on December 2025 – revenues in the first quarter of 2026 grew by 9.6% compared to the same period in 2025, continuing the previously mentioned organic growth path.

The **Net Financial Position** as of 31 March 2026 is “cash positive” at **€ 7.6 million**, compared to €12.0 million as of 31 December 2025. The variation mainly reflects the physiological absorption of cash due to the seasonality of working capital.
